If you choose not to file Form I-765 and/or Form I-131 with your Form I-485, then you must submit a copy of your I-797C, Notice of Action, receipt as evidence that you filed a Form I-485. If you filed your Form I-485 before July 30, 2007, you must pay the fees associated with Forms I-765 and/or I-131 when you file them.

Form I-485 Page 1 The Form I-485, Application to Register Permanent Residence is the form used to apply for Lawful Permanent Residence (also known as holding a green card). "Adjustment of status" (AOS) is the process by which an immigrant applies to adjust his or her status from "nonimmigrant" to "immigrant".

An I-485 is the actual form with which you apply for U.S. permanent residency. The USCIS (U.S. Citizenship and Immigration Services) governs and regulates immigration matters within the U.S. and you need to comply with their requirements to gain your permanent residency (or also known as a Green Card).

Per USCIS, Form I-485 needs to be filed to apply to adjust your status to that of a permanent resident of the United States. In this case i.e. marriage based green card, the Green Card applicant files Form I-485 to adjust his/her status to that of a Permanent Resident of the U.S., or simply put - to get a green card.

This form may also be used by certain Cuban nationals to request a change in the date that their permanent residence

Form I-485 Supplement A, Adjustment of Status Under Section 245(i) (Supplement A) (if applicable) Family Members: If you are the spouse or child of a U.S. citizen's immediate relative, you must independently qualify for adjustment of status and file your own application. You cannot qualify for adjustment of status as the derivative beneficiary based on the immediate relative's application.
