Entry into Pakistan is governed by the Passport Rules 1955. To enter into Pakistan a visa is generally required except in case of country which has reciprocal arrangements with Pakistan. All foreigners entering the country (not being Commonwealth citizens) must register with police within 24 hours. If they wish to stay in Pakistan after expiry of their visa, they must obtain permission of Police Department.

Immigration policy is overseen by the Interior Minister of Pakistan through the Directorate General Passports. Most immigrants are not eligible for citizenship or permanent residency, unless they are married to a Pakistani citizen or a Commonwealth citizen who has invested a minimum of PKR 5 million in the local economy.

Foreigners of Pak Origin are granted visa with multiple entries up to one year or validity of their passport, whichever is less by Missions abroad. Pakistan is not party to the Hague Convention on Protection of Children and Co-operation in Respect of Intercountry Adoption (Hague Adoption Convention).
